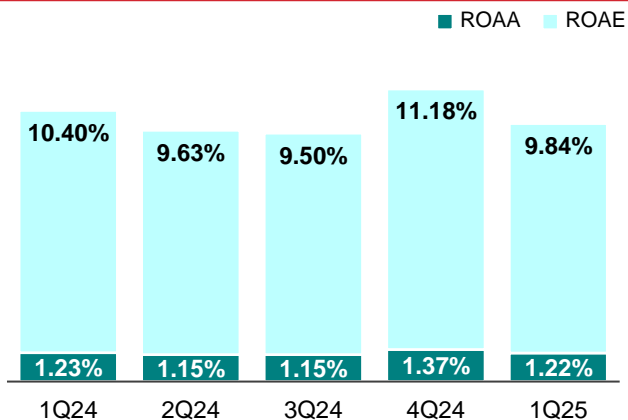

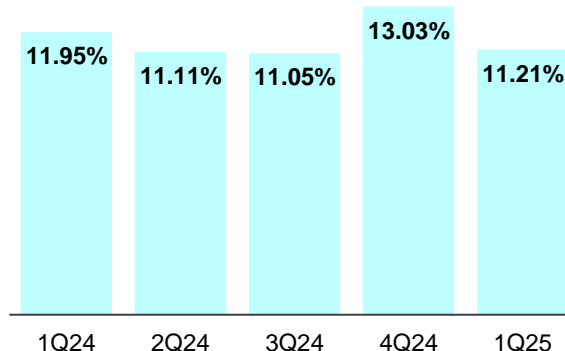

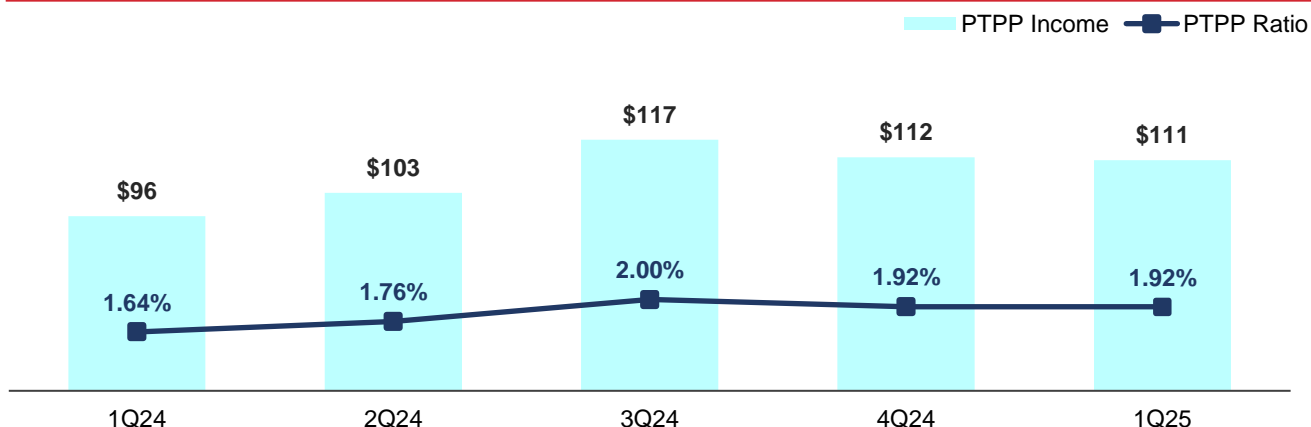

Pre-Tax Pre-Provision Income Ratio (\$mn)



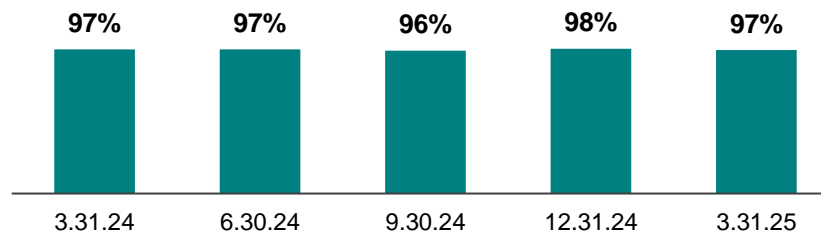

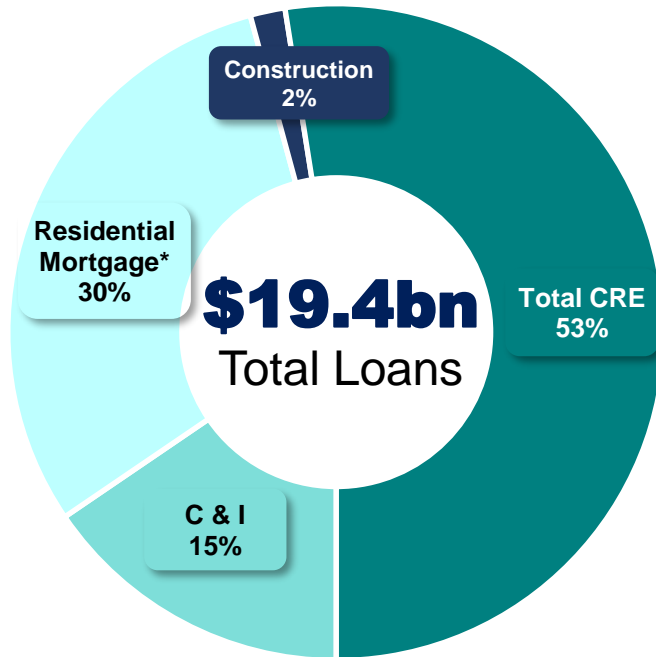

Net Loans-to-Deposit Ratio (end of period (EOP))



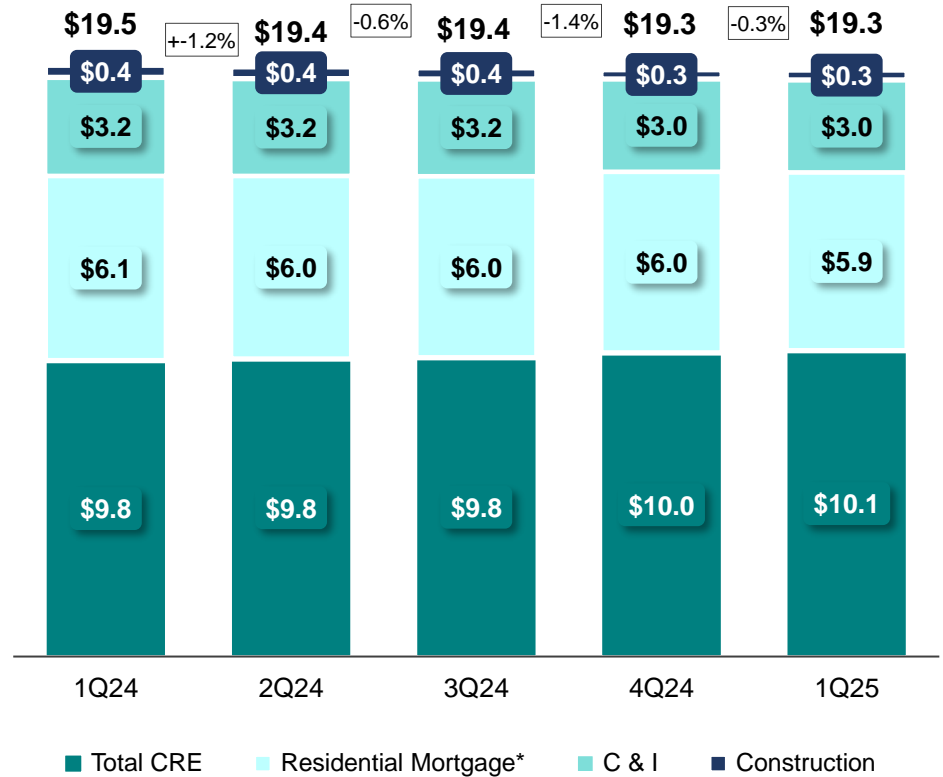

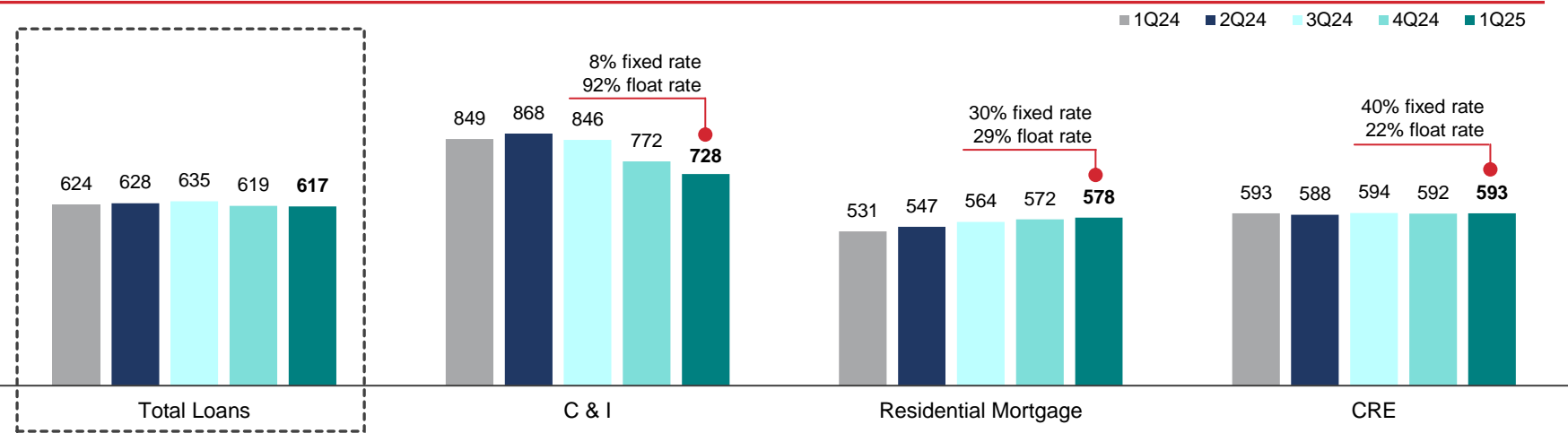
Average Loan Growth – QoQ Annualized (\$bn)



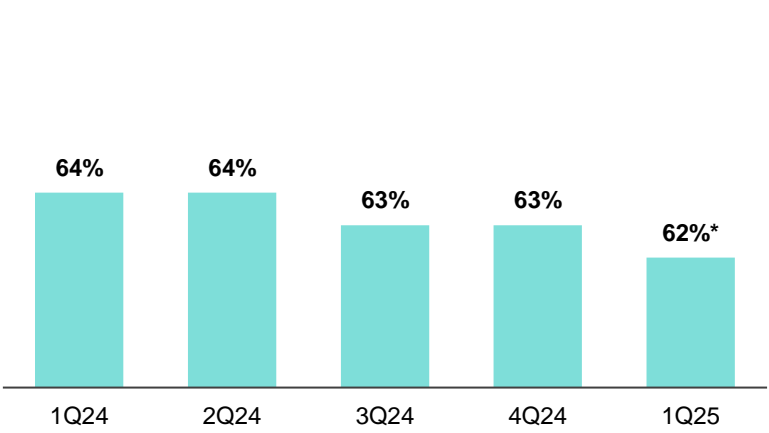

Average Loan Yield by Type (in bps)



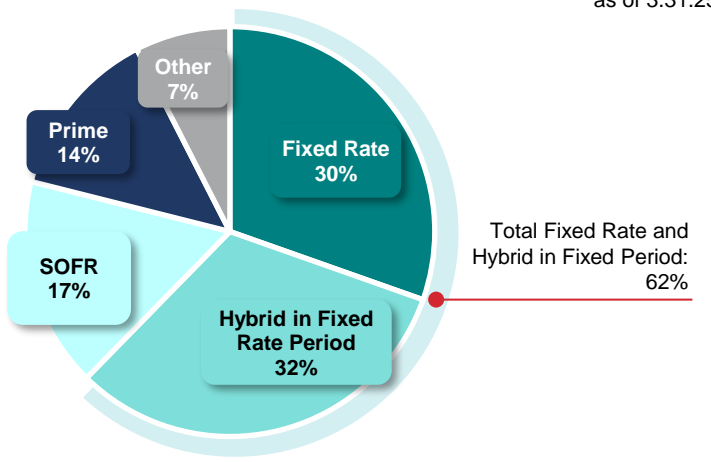
Fix Rate & Hybrid in Fixed Rate Period (% of total loans)

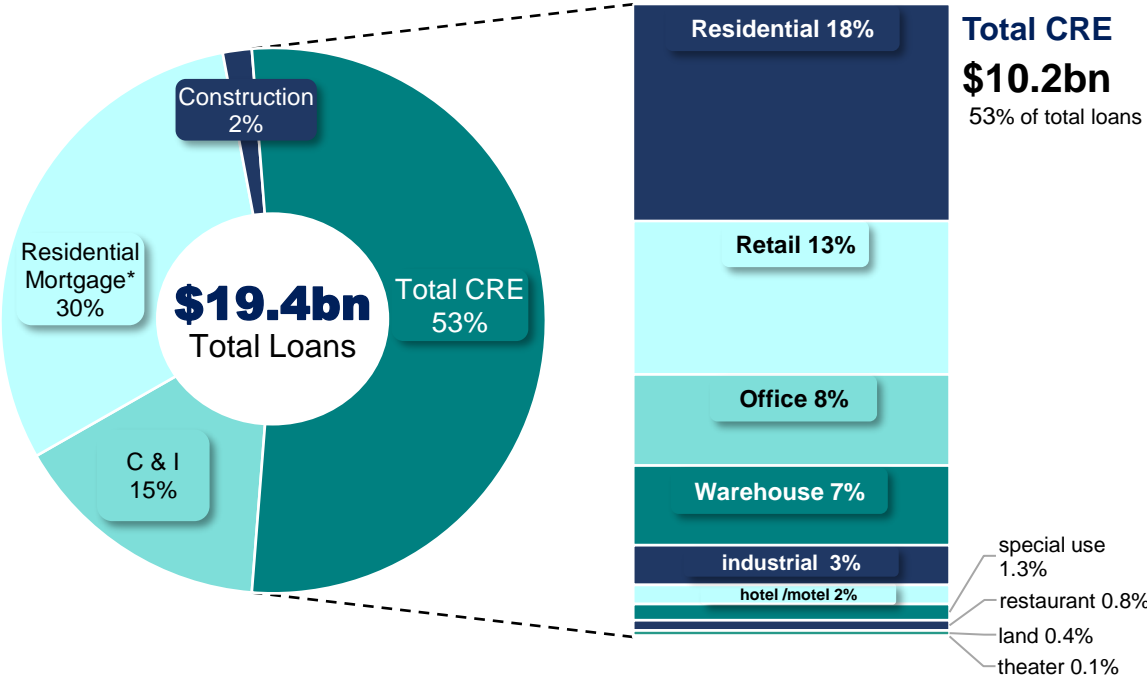
Loan Portfolio By Index Rate

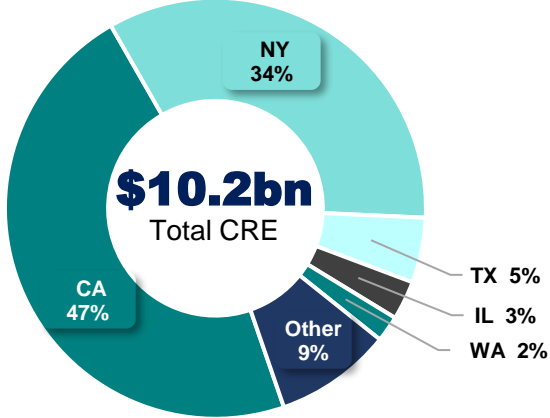
CRE Portfolio Breakdown



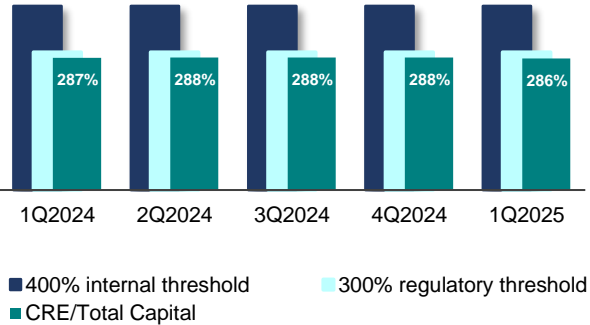

CRE Geographic Distribution

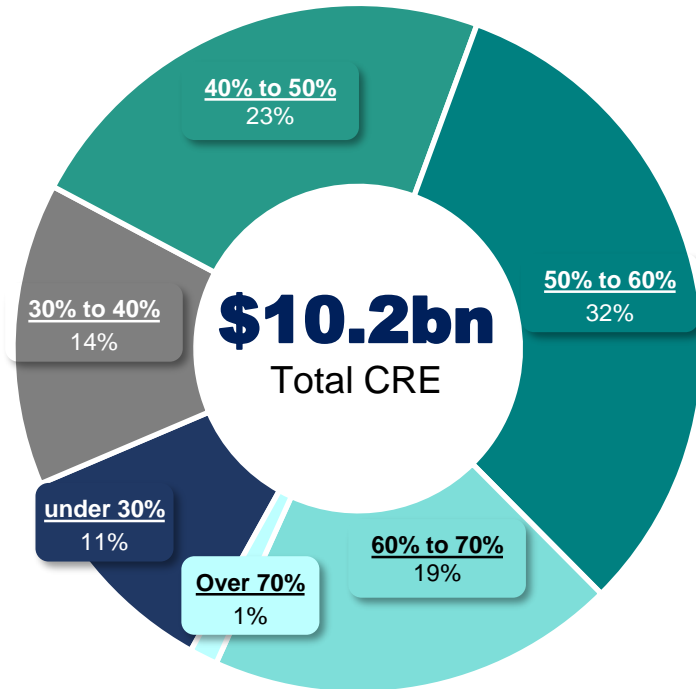


Total CRE Concentration

Total CRE LTV Distribution



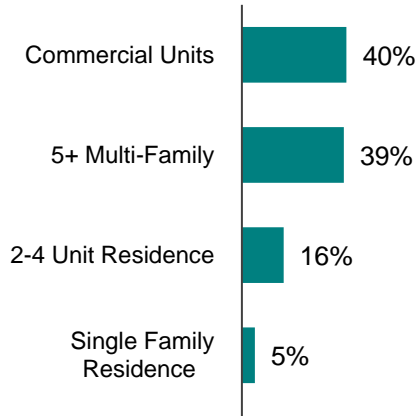

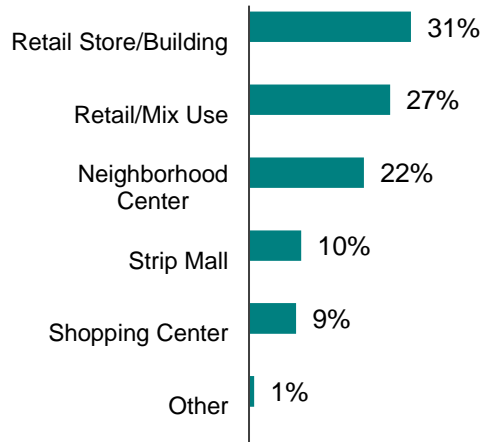
Residential CRE Portfolio

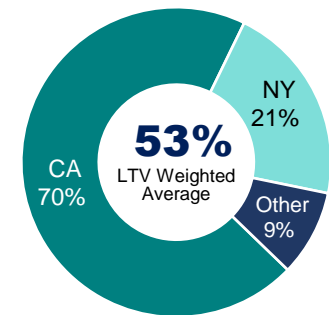

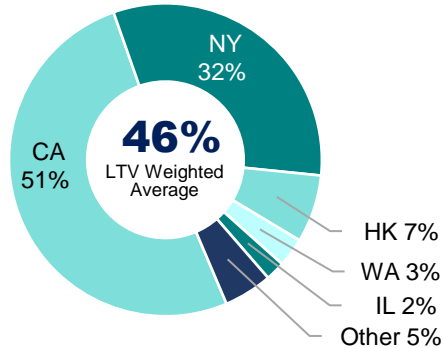
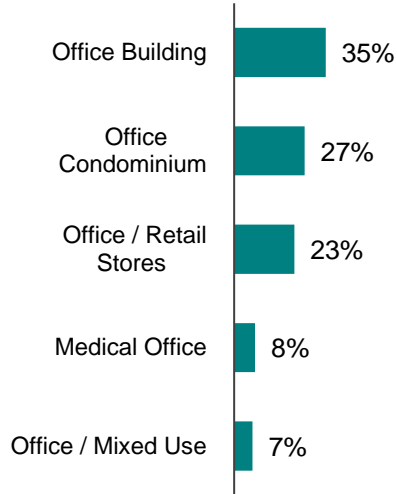

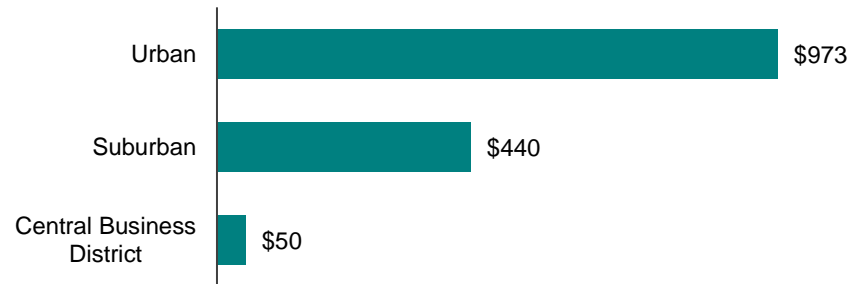

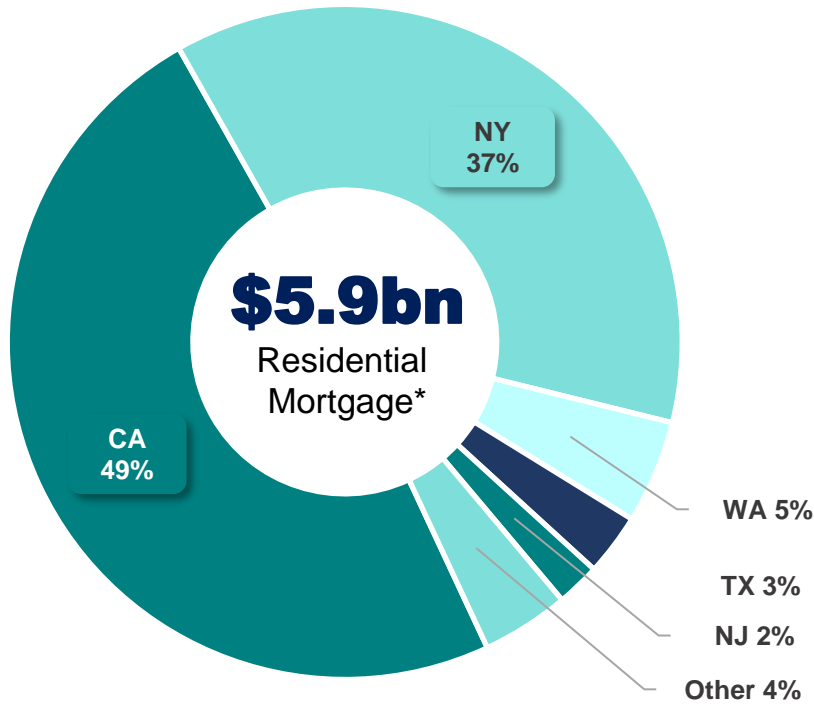
Office CRE Collateral Distribution (\$mn)



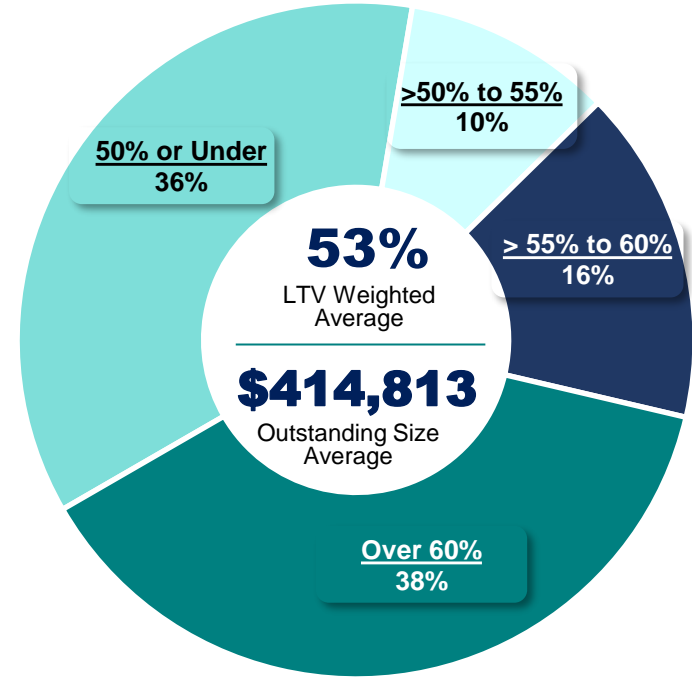

Resi. Mortgage Geographic Distribution



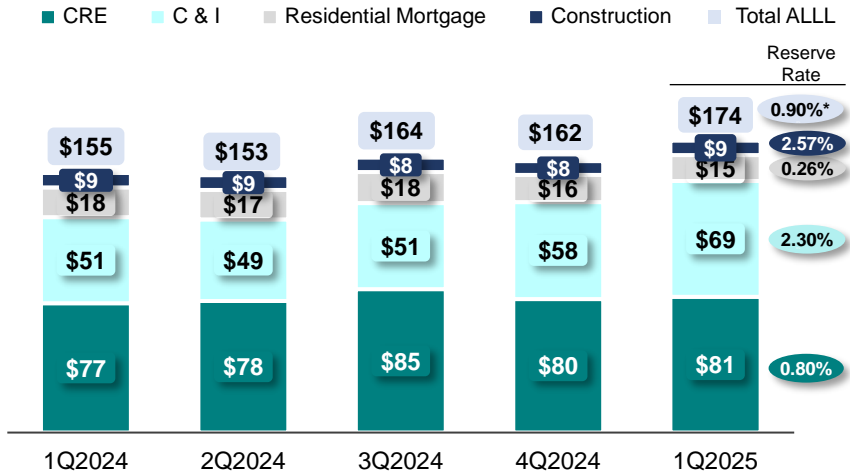
Single-Family Resi. LTV Distribution

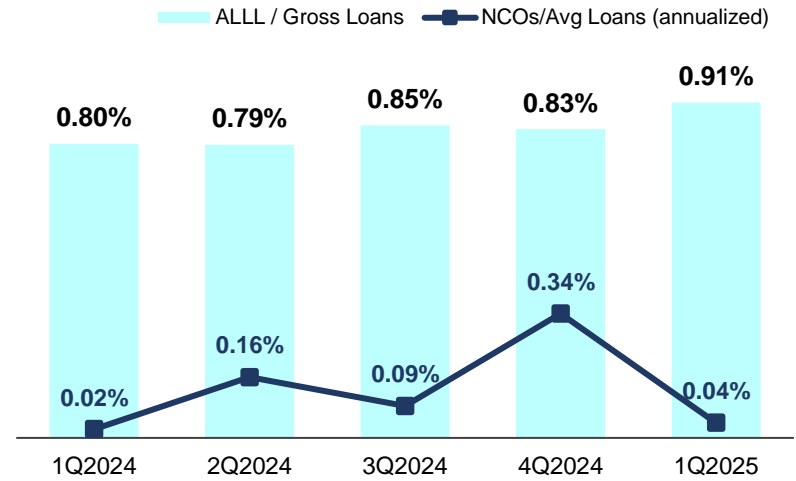

ALLL Composition (\$mn)

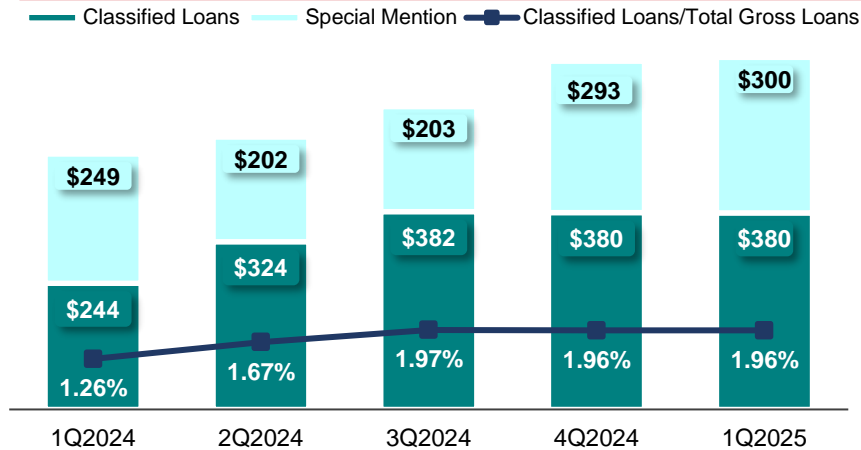

Reserves and Net Charge-Offs (%)

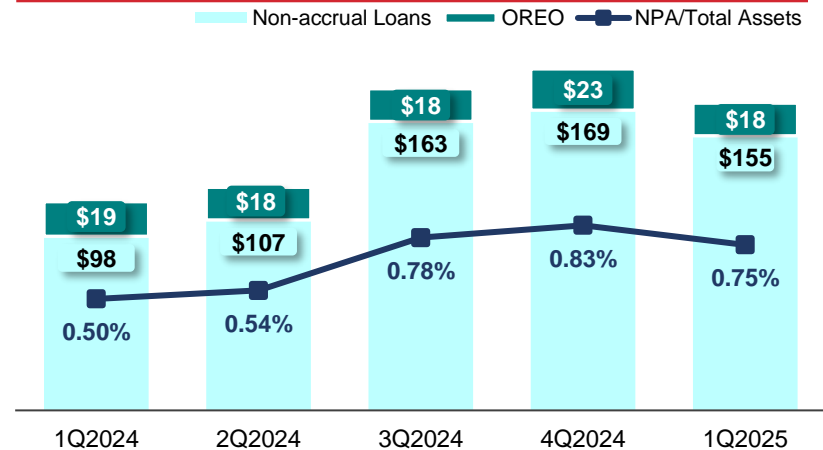


Classified Loans Ratio (\$mn)



Classified Loans are loans classified as substandard and doubtful.

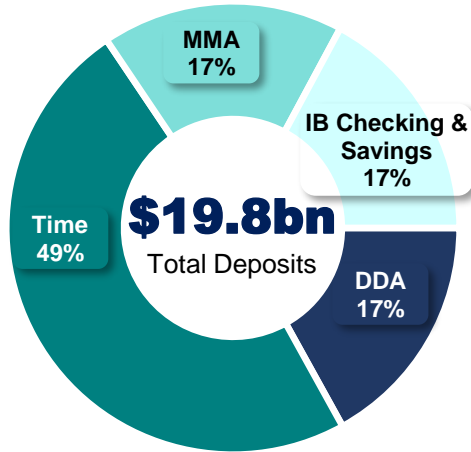
Non-Performing Assets Ratio (\$mn)



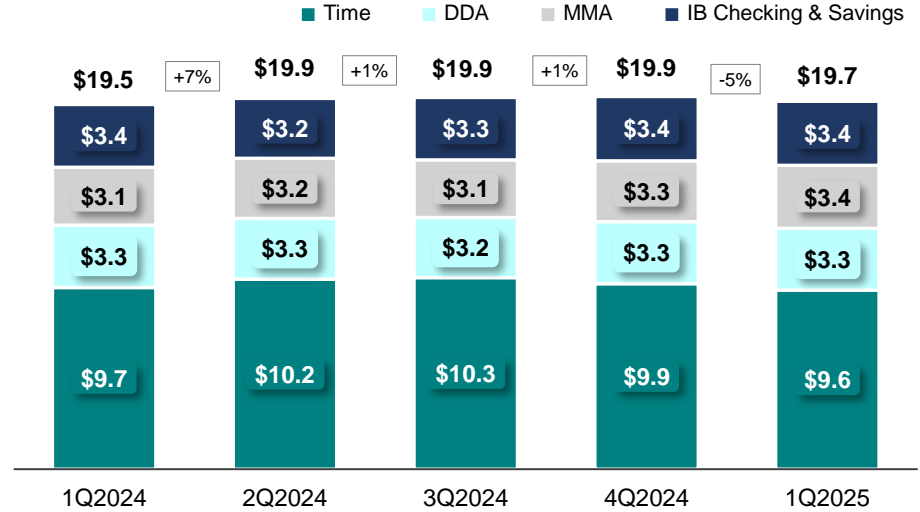

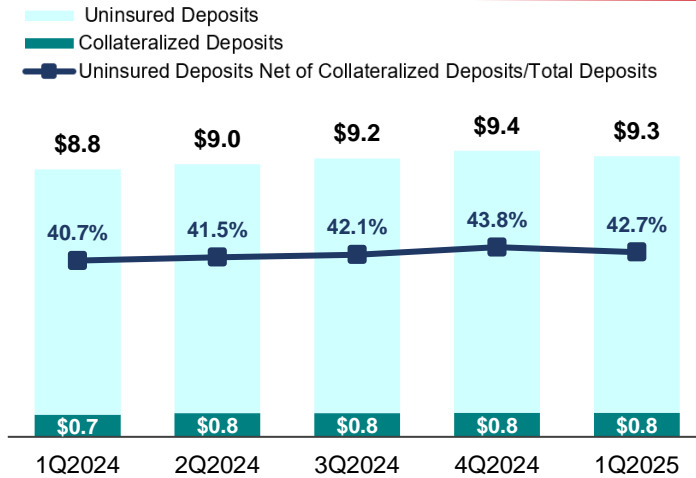
Total Deposits (\$bn)



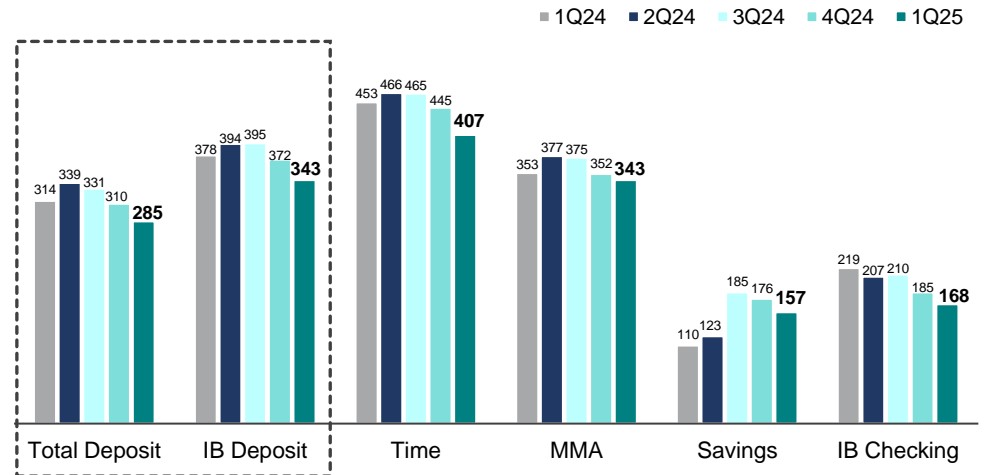
Average Deposit Growth – QoQ Annualized (\$bn)

Average Cost of Deposits by Type (bps)



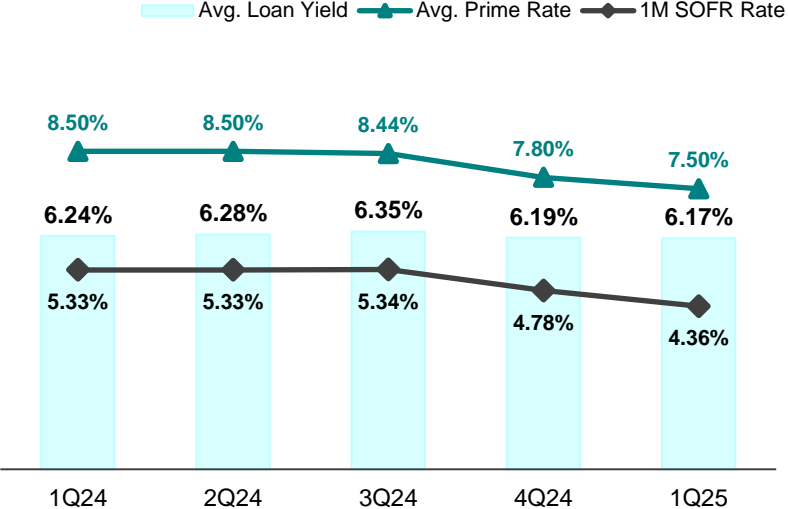

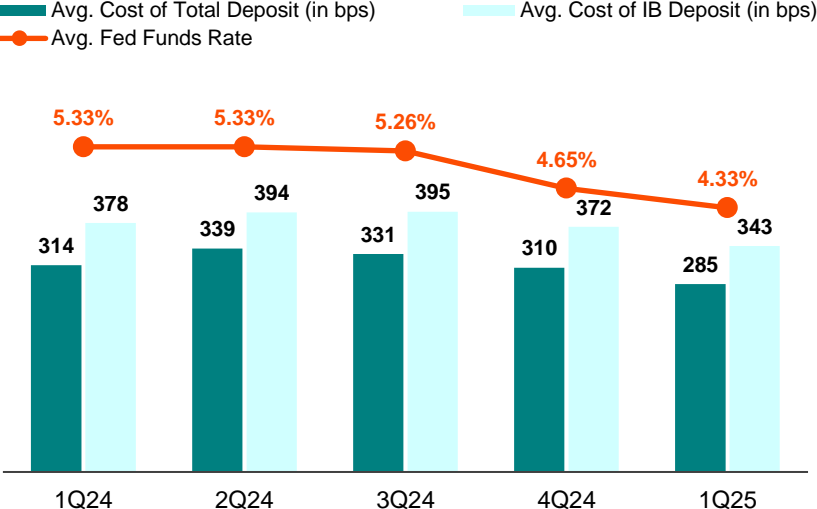

Loan Yields, Deposit Costs and Net Interest Income

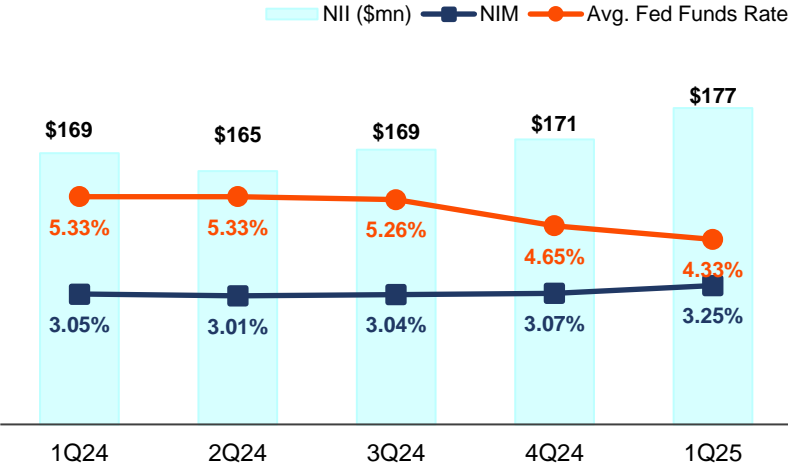
Average Loan Yield vs Prime Rate and 1M SOFR



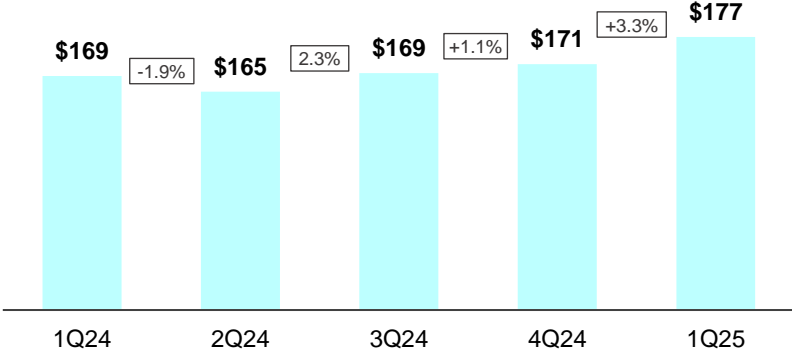
Average Cost of Deposits vs Fed Funds Rate



Net Interest Income and Net Interest Margin

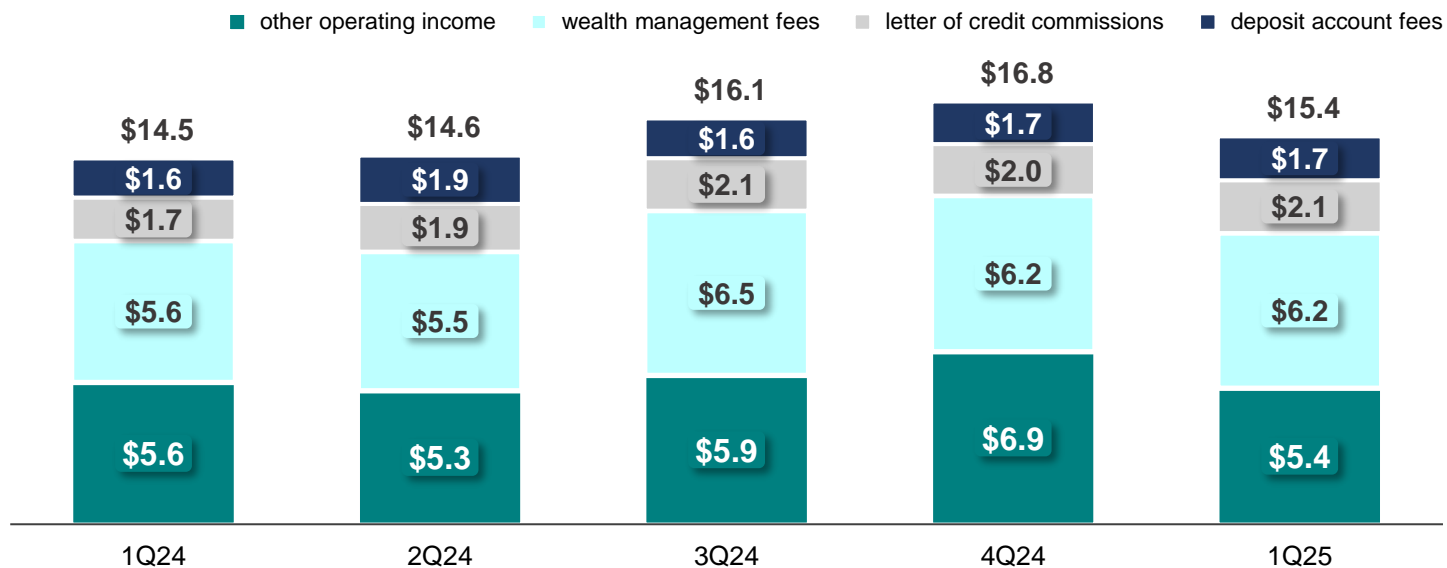


Net Interest Income Growth (\$mn)

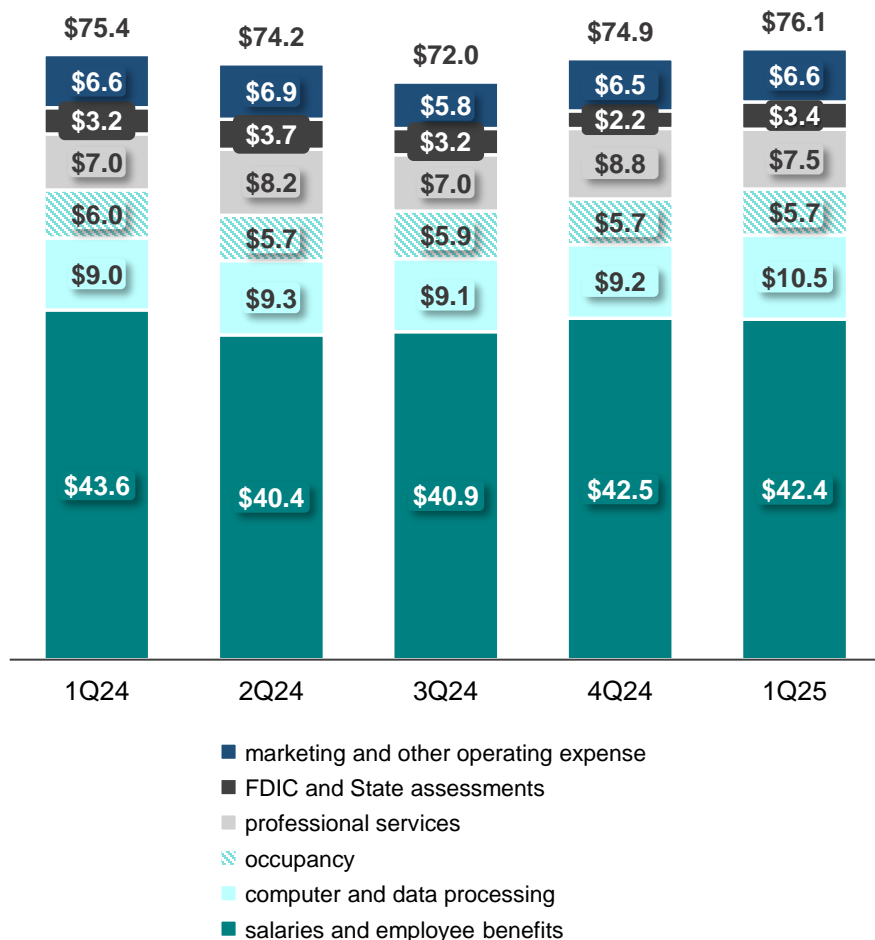

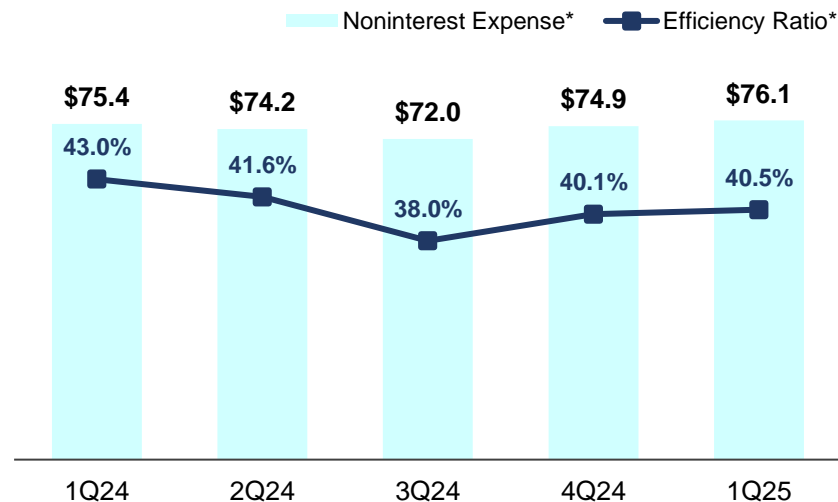
Operating Expense & Efficiency

Core Noninterest Expense* & Efficiency Ratio* (\$mn)



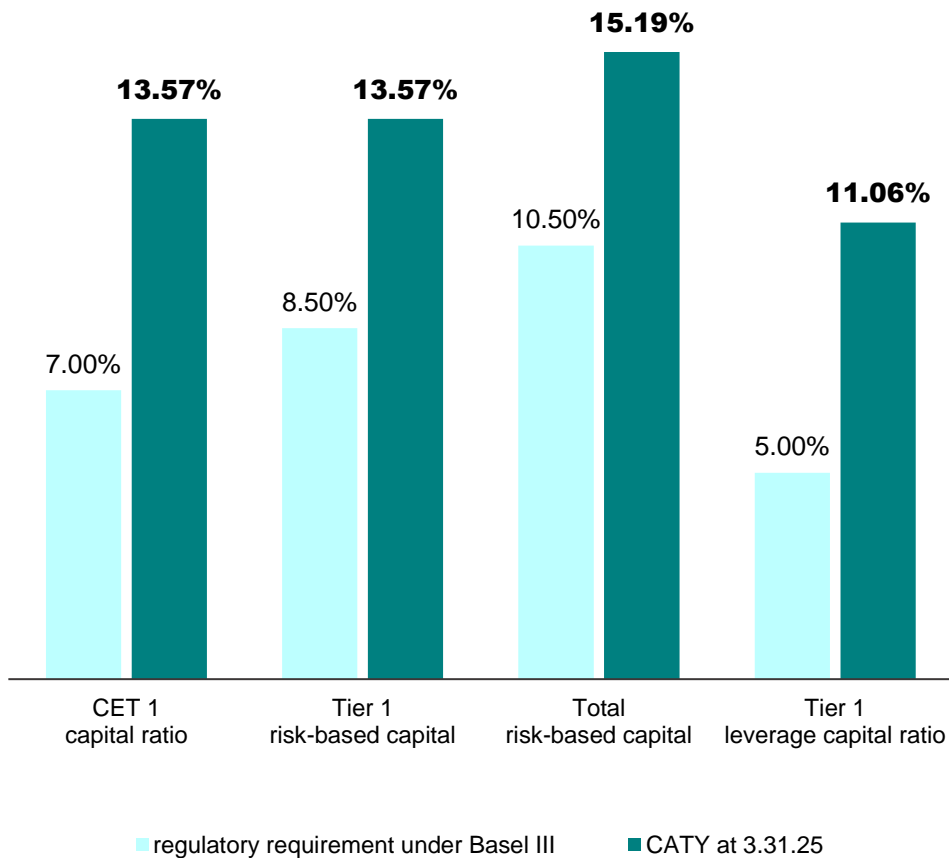

Highlights

- **Capital Ratio** well above regulatory standards that continues to place Cathay in the “well capitalized” category, calculated under the Basel III capital rules.
- **Book Value Per Common Share** is \$40.91 as of 3.31.25: +1.87% compared to 12.31.24 and +7.04% YoY.
- **Tangible Book Value* Per Common Share** is \$35.50 as of 3.31.25: +1.98% compared to 12.31.24 and +7.61% YoY.
- **Capital Return on Shareholder**
 - common stock dividend: \$0.34/share quarterly, or \$1.36/share annualized.
 - stock buyback: repurchased 876,906 shares at avg. cost of \$46.83/sh. in first quarter.
